In this annual report, we share with you the details of our monumental win in Arizona, where a lawsuit we filed resulted in the repeal of a state law barring LGBTQ education and support in schools. And no story of our successes can be told without bringing attention to our immigration and asylum cases — more than 400 cases and a 100% success rate for our asylum-seekers.

The fight against Conversion Therapy — now outlawed in 18 states thanks to our "Born Perfect" Campaign — continues to be a cornerstone of our work. We won't stop until all 50 United States ban this horrific practice.

We fight for racial justice and for the safety and wellbeing of LGBTQ communities of color. We will continue to take on the hardest battles for the transgender members of our community. NCLR's vision is intersectional, inclusive, and forward-looking. We leave no one behind.

The deck is stacked — but NCLR's staff includes the best legal minds in the movement, and the courage to stand up for LGBTQ families, elders, and youth ... with humanity, inclusivity, and ferocity.

NCLR is a **nationally recognized LGBTQ legal organization with a longstanding commitment to racial and economic justice and our community's most vulnerable**. Since 1977, we have been a leader at the forefront of advancing the civil and human rights of LGBTQ individuals and their families through impact litigation, public policy, and public education.

Over our 42-year history, we have been commited to our community's most vulnerable and to breaking new ground, a commitment that led to NCLR launching the first LGBTQ Immigration Project, Transgender Rights Project, Youth Project, Elder Law Project, Sports Project, Rural Pride, and the **creation of our Born Perfect campaign to end conversion therapy in 2014**. In 2019, with the help of the Born Perfect Campaign, North Carolina became the first state in the South to protect vulnerable young people from conversion therapy.

Over the past year, NCLR has also been on the front line fighting to protect **reproductive justice rights for LGBTQ individuals**, to **challenge the Trump administration's transgender military**  **ban**, to advocate for **LBGTQ immigrants and asylum-seekers**, and to **repeal the harmful Arizona "No Promo Homo" law** that barred LBGTQ public school students from receiving accurate health education information.

But the struggle for full LGBTQ equality is not over, and **NCLR will continue fighting the fight**, including against the Trump administration's recent attack on our rights at the Supreme Court, arguing that federal law should not protect LGBTQ Americans from being fired for their sexual orientation or gender identity.

For many in our community, help can't wait. And we won't either. We will be here when you need us. Every time.



## CASE HIGHLIGHT Victory for LGBTQ Students in Arizona

or 28 years, Arizona barred LGBTQ students from receiving medically accurate, ageappropriate information in their health education classes about non-heterosexual people. Despite repeated attempts over the years to repeal this harmful law, it remained on the books.

That is, until NCLR and our partners filed a federal lawsuit challenging this law in March 2019.

Our lawsuit argued that the anti-LGBTQ curriculum law, which was enacted in 1991, violated the Equal Protection Clause of the U.S. Constitution by singling out a group of students for unequal treatment based on their sexual orientation. And it harmed LGBTQ students by preventing educators from including or discussing them in a positive light, fostering a climate of hostility and harassment against LGBTQ students.

Two weeks after we filed suit, the Arizona legislature introduced, passed, and sent to the governor a bill to strike down this "No Promo Homo" (as it's commonly known) law. When Governor Ducey signed the legislation, it put an end to this hateful law once and for all in Arizona.

What a victory for our plaintiff Santi Ceballos, their family, and all LGBTQ students in Arizona! But there are still six states with "No Promo Homo" laws still on the books, so our work continues.


